(B) The Rise and Fall of the South Australian Disability Justice Plan

In 2016 the then Attorney General, John Rau, introduced his Disability Justice Plan. The program sought to introduce a new deal to persons with intellectual and physical disabilities who found it profoundly difficult to be fairly treated in their interactions with the criminal justice system whether they be victims, defendants or witnesses.

Under the Plan, the instruments of criminal justice – the Courts, police, prisons and lawyers – were urged to undertake disability awareness training and to change their practices to meet the needs of people with disability.

Nearly 10 years on, has anything really changed? The speaker will address the history of the Disability Justice Plan highlighting the difficulties that people with disability face within a justice system that seems to have abandoned them.
